### **Responsibility**

Uncommon Journeys, LLC, its owners, agents, directors, shareholders and employees assume no responsibility for any injury, loss, damage, delay, or death to person or property arising from the negligent or willful act, or failure to act, of any person who is to or does provide goods or services for this trip, or for the action or inaction of any other third party. Without limitation, Uncommon Journeys LLC is not responsible for acts of God, equipment failures, vehicle accidents, illness from food or otherwise, detention, assaults, theft or criminal activity, annoyance, delays, quarantine, strikes, failure of any means of conveyance to arrive or depart as scheduled, civil disturbances, terrorism, government restrictions or regulations, and discrepancies or changes in transit or hotel services over which it has no control. Reasonable changes in the itinerary may be made where deemed advisable for the comfort and wellbeing of the passengers. We reserve the right to substitute hotels, alter the itinerary, and reverse the order of places to be visited.

### **Refusal of Participation**

Such participant may be left at any place on the tour, without liability to Uncommon Journeys, LLC. Uncommon Journeys, LLC shall not be required to refund any amount paid by the participant who must leave the tour prematurely for any reason, nor shall Uncommon Journeys, LLC be responsible for lodging, meals, return transportation or other expenses incurred by the guest.

### **Release of Liability**

I understand that travel in remote or developed areas entails inherent risks, including but not limited to: high altitude, rugged and mountainous terrain, forces of nature, civil unrest, and travel by plane, train, bus, automobile, horseback, or on foot. I further understand that medical services or facilities may not be readily accessible during some or all of the time in which I am participating in a trip arranged by Uncommon Journeys LLC. In consideration of the right to participate in the trip, I do hereby fully assume all risk of illness, injury, property damage, or death, and hereby release and discharge Uncommon Journeys, LLC and its agents and associates from all actions, claims, or demands for damages resulting from my participation in the trip. This release of liability shall be binding upon me personally, as well as upon my heirs, executors, and all members of my family.

### **Preserving the Burmese Culture**

We are proud of our 20 year track record of operating tours in the magical land of Burma. We were among the first and have operated continuously, through thick & thin, since 1998. It has been, and remains, our passion. Recent growth in tourism has been a mixed blessing. Well-intentioned but misguided tourists have taught the Burmese people to beg for money, candy, pens, toys, lipstick and trinkets. These handouts belittle the people, erode the local culture, perpetuate a negative stereotype of patronizing foreigners, and create reliance on begging. They also encourage parents to exploit their children by sending them out to beg from tourists instead of going to school. We are determined not to allow our presence to further endanger the graciousness of the Burmese way of life. In order to preserve the culture and dignity of the people, we enforce a strict policy against handouts. If you feel it would be difficult to comply with our policy, you should reconsider before signing up for the tour. On the other hand, if you share our philosophy of sustainable tourism and our commitment to preserving this gentle culture and dignified way of life, we look forward to sharing our love of Burma and the trip of a lifetime with you.
